ORDINANCE 2017-001 TOWN OF WAVERLY, ALABAMA

AN ORDINANCE TO PRESCRIVE AND FIX LICENSES FOR EXHIBITION, TRADES, BUSINESS, VOCATIONS, OCCUPATIONS, AND PROFESSIONS IN THE TOWN OF WAVERLY, ALABAMA AND THE POLICE JURISDICITON THEREOF, FOR THE YEAR BEGINNING JANUARY 1, 2018 AND EACH SUCCEEDING YEAR THEREAFTER.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF WAVERLY, ALABAMA, AS FOLLOWS:

Section 1. LICENSE SCHEDULE. That the following be and the same is hereby declared to be schedule of LICENSES beginning January 1, 2018, and each succeeding year thereafter, and each person, firm or corporation engaged in any business, trade, or profession, or keeping or carrying on any establishment or other things, or doing any act in this Section specified, within the corporate limits of the Town of Waverly, shall pay an annual LICENSE therefore, as follows:

- 1. Advertising, agent contracting for or with bills to resident merchants: Per day \$1.50
- 2. Advertising on streets, by out-of-towner advertisers with banners, posters, floats, circular or any means:

 Per day \$4.00
- 3. Agencies, persons, firms or corporations having an office in the Town of Waverly, Alabama, but representing persons, firms or corporations and doing business outside the Town of Waverly, Alabama but within the State of Alabama without regard to interstate business: \$75.00
- 4. Agents for books, magazines, periodicals, photographs, pictures frames or other articles of this kind taking orders from door to door without pre-arranged appointments and making immediate delivery or later delivery:

Per day \$25.00 Per annum \$75.00 5. Agents, Real Estate, doing business within the Corporate Limits of the Town of Waverly, Alabama having an office within the Corporate Limits of the Town of Waverly, Alabama. \$75.00

Agents, Real Estate doing business within the Corporate Limits of the Town of Waverly, Alabama having an office outside the Corporate Limits of the Town of Waverly, Alabama \$75.00

- 6. Auctioneer, public, resident or transit Per day \$25.00 Per annum \$30.00
- 7. Automotive dealers, or sales agencies dealing in new or used cars \$75.00
- 8. Automotive, repair and maintenance, garages \$75.00
- 9. Baker's Products, wholesale dealers in when sold and delivered from wagons, automobiles, trucks or other vehicles from a place of business without the Corporate Limits of the Town of Waverly, Alabama to retail dealers within the Corporate Limits of the Town of Waverly, Alabama, each person, firm, or corporation \$75.00
- 10. Barber shops, up and including two chairs \$75.00Each additional chair \$5.00
- 11. Brewed or malt beverages, vinous liquors. Any person, firm, corporation, or distributor inside the Corporate Limits of the Town of Waverly, Alabama. \$75.00
- 12. Bottle or canned drinks. Wholesale dealers, manufactures, or bottlers of, when sold and delivered from wagons, automobiles, trucks and other vehicles from a place of business without the Corporate Limits of the Town of Waverly, Alabama, to retail dealers within the Corporate Limits of the Town of Waverly, Alabama, each person, firm or corporation.

- 13. Builders and contractors doing business in new construction from ground to finish product or remodel exceeding \$50,000 within the Corporate Limits of the Town of Waverly, Alabama \$200.00
- 14. Builders and contractors doing business in remodel less than \$50,000 within the Corporate Limits of the Town of Waverly, Alabama \$75.00
- 15. Beauty Parlors. Up to and including two operators.\$75.00\$7.50 each additional operator
- 16. Buses or Motor Freight Lines. Each person, firm or corporation operating a bus or motor freight line for the transportation of passengers, express to freight, for hire, to and from points within the State of Alabama. \$75.00
- 17. Butane or propane gas. Each person, firm or corporation engaged in the business of selling, dealing in or delivering butane gas or other gas used or suitable for heating, cooking, lighting or fuel for appliances within the Corporate Limits of the Town of Waverly, Alabama \$75.00
- 18. Café, Cafeteria, Restaurant. \$75.00
- 19. Clothes cleaning or pressing, or both. Each person, firm or corporation engaging in business of picking up and delivering clothes within the Corporate Limits of the Town of Waverly, Alabama, for the purpose of cleaning or pressing or both. \$75.00
- 20. Dairy Products Wholesaler. When sold and delivered from wagons, automobiles, trucks and other vehicles from a place of business without the Corporate Limits of the Town of Waverly, Alabama, to retail dealers within the Corporate Limits of the Town of Waverly, Alabama, each person, firm or corporation.

- 21. Exterminators. Persons, firms or corporations providing pest control services to businesses or residences within the Corporate Limits of the Town of Waverly, Alabama (Must present State of Alabama Certification) \$75.00
- 22. Fireworks. Dealers in those fireworks legal under the laws of the State of Alabama \$75.00
- 23. Furniture and appliances. Each person, firm and corporation who delivers, distributes, or disposes of furniture, appliances, household goods, etc., within the Corporate Limits of the Town of Waverly, Alabama, from a place of business without the Corporate Limits of the Town of Waverly, Alabama.

- 24. Fortune Tellers, Palm Readers, Hypnotists, Etc \$75.00
- 25. Gasoline Wholesale Dealers. When sold and delivered from trucks and other vehicles from a place of business without the Corporate Limits of the Town of Waverly, Alabama to retail dealers within the Corporate Limits of the Town of Waverly, Alabama \$75.00
- 26. Insurance Companies Life, Health, Accident, etc \$10.00

And \$1 on each \$100 and major fraction thereof the gross premiums less return premiums, received during the preceding year on policies issued during said year to citizens within the Town.

27. Insurance

- (a) Fire, Marine, and Allied Lines
- 4% on each \$1 and major fraction thereof of the gross premiums (less return premiums) on policies issued during the preceding year on property located within the Town of Waverly, Alabama
 - (b) Automobile Fire, theft, tornado, collision, property damage, and public liability. 4% of the gross premiums (less return payments) on policies issued during the preceding year on automobiles purchased

for cash or on installment plan located within the Town of Waverly, Alabama; provided that each person, firm or corporation that has not done business during the preceding year in the Town shall pay a license of \$75.00

And, there shall be an adjustment at eh end of the year of such license hereinabove specified. Each person, firm or corporation doing an insurance business within the Corporate Limits of the Town of Waverly, Alabama, shall within 60 days of the adoption of the Ordinance, make a statement under oath in writing to the Town Clerk, giving he name of the company, showing the amount of business written within the Town for the past twelve months and the amount of premiums returned. And such statement shall be made by the first day of January of each succeeding year. Provided, that any person failing or refusing to make such statement as required or make a false statement willfully, shall on conviction, e fined not more than \$100 (one hundred dollars), and in addition thereof, shall forfeit to the Town, double the amount of license tax hereinabove required.

- 28. Lumber or pulpwood dealers. Any person, firm or corporation maintaining, within the corporate limits of the Town of Waverly, Alabama, a lumber or pulpwood yard for the purpose of assembling lumber of pulpwood for sale or distribution within or without the corporate limits of the Town of Waverly, Alabama \$75.00
- 29. Machines. Coin operated in stores, or other buildings in the Corporate Limits of the Town of Waverly, Alabama \$75.00
- 30. Merchandise. Each person, firm or corporation selling merchandise, retail or wholesale, whether consigned or purchased \$75.00
- 31. Power Companies. Each person, firm or corporation engaged in the business of selling or distributing electrical current shall pay the Town of Waverly, Alabama, an amount equal to three percent (3%) of the gross receipts for the business transacted by such person, firm, or corporation in the Town of Waverly, Alabama, for the preceding year from the sale of electrical current sold or distributed from any point or points in the Town of Waverly by such person, firm or corporation for any purpose whatsoever. Each such person, firm or corporation shall pay to the Town

of Waverly, one and one half percent (1 ½%) of the gross receipts for the preceding year for business transacted by such person, firm, or corporation outside the Corporate limits, but within the Police Jurisdiction of the Town of Waverly, Alabama. Application for such license shall be accompanied by a statement by the president or manager of said light or power company, or the owner, thereof, giving the names of the person, firm or corporation owning and operation such plant. Said statement to be made to the Mayor of the Town and give the principal place of business of said person or corporation, together with a statement, under oath, of the gross receipts of said plant within the Town and Police Jurisdiction thereof the preceding year.
